**Treasurer's Report:** Treasurer's report for September has been posted to the La Jolla Unit Web site. Each month's report is different based on incoming money from various sources. Topic of discussion included the Vanguard CD account. The Treasurer (Diana Marquardt) and one other unit board member need to be signatories on the Vanguard account.

**Membership Report:** Total membership = 265 members as of October 1, 2008. This is a slight decrease from September due to the differences/re-alignment in Zip Codes. **2009 May Sectional:** 4-day Sectional. No schedule is prepared as yet, but Nate will have a tentative schedule for the next meeting. A 2-session event will be held on Memorial Day Monday with the Team Game on Sunday. Rental for the proposed playing site (Adventures in Bridge) is \$500.00 per day. Rental fee includes Coffee, Tea, etc. Cleaning is also included. No formal contract is as yet signed, but Nate does have a verbal agreement with Wirt Gilliam.

**Bridge At La Jolla High:** Ron reported that the High School will form a Card Club (bridge is just one of the games). Nothing is firm as yet as to how to get High School Bridge off the ground. We will probably “spin” the game of Bridge into a mathematics focus in order to generate more interest from the High School administration and teachers. There is obviously more work needed to be taken care of before this becomes a reality at the High School.

**Christmas Party:** Elijah’s Catering will do the Christmas party. A contract for the Party has been signed. Elijah’s will do the party as a Brunch Style (eggs, sausage, etc.) buffet. Cost is \$10.00 for members and \$20.00 for non-members. Door prizes were discussed. Discussion include perhaps bottles of champagne or Christmas ornaments. Diana Marquardt will solicit for volunteers for help. Steve Johnson will help with Flyers. Other board members will help with clean-up. An extra caddy will possibly be required for the party.

**La Jolla Unit Web Site:** Lots of new tools on the site, including hand analysis.
